



Consent cum Declaration Form

We confirm that we are **seeking continuation** of our ward _____ studying in Grade ____Section__ of Amanora School for the AY 2018-19 after having read and understood the terms and conditions stated herein below. We confirm that we shall pay first instalment of fees for the AY 2018-19 on or before 1st April, 2018.

We unconditionally accept and agree to abide by the School rules (which are also listed on School's website) without any kind of pressure, duress or coercion of any nature whatsoever in this behalf by the management or Amanora School authorities.

- 1) We hereby solemnly declare that we have signed this Declaration form seeking continuation for our child after having read and understood all the rules of School and declare that the information furnished by us to the School is true to the best of our knowledge and belief.
- 2) We declare that we shall at all times abide by the instructions contained in the Student diary as amended from time to time, and or another rules, regulations etc. of Amanora School as may be specified from time to time by way of circulars or otherwise.
- 3) We fully understand and accept that the fee is required to be paid each year before the commencement of the Academic Year, or as and when demanded before the intimated due date and that the fee once paid, shall not be refunded in any case whatsoever. We also understand that while Amanora School may at its sole discretion, permit or grant the facility to pay the fees in one or more instalments, the same does not in any manner vest any right in the parents to demand for marking payment of fees by way of instalments.
- 4) We will deposit the school fees on or before the prescribed date. In case of any cheque towards payment of fees being dishonoured, the management reserves the right to de-enrol the child at its discretion and levy any other penalty as it may deem fit. In case of non-compliance, at the end of 30 days, the name of the student will be struck off from the Attendance Register. We understand that non-payment of the fees in time will be considered as our non-willingness to continue the admission of our ward in the school for the remaining period of the academic year.
- 5) The management reserves the right to disallow our ward from attending Amanora School or participating in any of its activities if his/her fee is not paid either in part or in full.
- 6) Amanora School reserves the right to increase/revise/amend the fee structure as may be required from time to time in view of any change in government policies and/or the economic conditions (including, but not limited to, inflation, etc.)
- 7) We understand that Amanora School is a permanently unaided school permitted as a self-financed school under the concerned legislation of the state government of Maharashtra.
- 8) We understand that in case we choose to withdraw our child from Amanora School, it will result in Amanora School not being able to offer the same seat to another child, whose parents may have been desirous of seeking admission here, and hence we agree and accept that the fees once paid shall not be refundable and if not paid shall have to be paid, failing which, we shall not be entitled to demand

for the Bonafide Certificate / Transfer Certificate. The Transfer Certificate / Bonafide Certificate will be issued only after all our dues are settled.

9) We agree and understand that if our child leaves Amanora School campus without permission, the management is authorized to lodge the necessary complaint with the Police authorities and that the organization will not be responsible for any mishap or untoward incident that may take place in such circumstances.

10) We understand and accept that our child may be expelled from Amanora School, if the Management (at their absolute discretion) determine that we, any one of us, has engaged in the one or more of the following:-

Participated in any dharnas and/or morchas, any communication whether in form of mails or SMS or otherwise, Initiated and/or participated in the filing of any frivolous complaints against Amanora School /its Management/ any of its staff member; Causing to be published or telecast in any form of electronic/paper media anything that in any manner whatever seeks to lower or tarnish the reputation of Amanora School and its Management and its staff member or participated in shouting of any slogans that are in any manner whatsoever derogatory to Amanora School/ its management/any of its staff members.

11) The student is governed by Amanora School's prohibited policy and list, which can be amended from time to time and the rules governing student conduct as per the student diary.

12) We hereby authorize Amanora School:

- a. To record our child's testimonial and image on film, photograph, electronically or any similar medium for their marketing and advertising purpose(s).
- b. We grant our permission to use our child's testimonial and image throughout the world of marketing and advertising campaigns in all and any media, in its original format or edited or altered in any way which the school deems appropriate.
- c. We do not object to the school for storing copies of the testimonial and image for marketing purpose or to its storing our contact details on its database in case it needs to contact us.
- d. We understand that we will not receive any financial compensation or payment in consideration for this release and that the above condition will be in place for a period of 6 years from the date of signing this Form.

13) We agree and understand that Amanora School will do its best to provide normal medical aid, but Amanora School or any member of its staff will not be held responsible for any unavoidable incidents/mishaps/ accidents despite its best efforts. This applies also to all accidents which may occur during the educational tours or journeys to and from Amanora School. We understand and agree that in an emergency, the school staff may need to exercise their discretion by taking the child to the nearest Medical Centre/Hospital.

14) We hereby declare that we will not be a part of any unauthorized or illegal vehicle pool as a mode of transport for our child and will furnish all required documents of any private vehicle pool to be used for mode of transport for our child.

15) We understand that the policies & rules listed in this publication have been put in place for the effective functioning of Amanora School. The School reserves the right to amend the policies & rules

whenever & whenever considered necessary & appropriate. Therefore this publication is an indication of Amanora School's plan at the time of publishing & is subject to change.

- 16) We, the parent /guardian appreciate and understand that Amanora School follows the policy for inclusion of children with special needs. If the counsellor/special educator indicate that our child requires special assistance, we shall bear the cost involved to hire a special assistant to provide assistance based on the approval of the Management. We agree to abide by any decision that the counsellor/special educator takes in the best interest of our child.
- 17) We give our irrevocable consent to the school management in general and the school staff in particular to allow our child to travel via transport arranged by the school in conjunction with school bus operators to playgrounds, club, coaching academies, field trips, excursions, picnics, carnivals etc. from time to time.

We have carefully read the above statement and agree to abide by the policies, rules and regulations or any substitutions for or modification in them which may be made by Amanora School authorities from time to time.

We have carefully read, understood and agreed to all the points mentioned in this declaration and undertake to abide by the same in full, failing which, the institute is free to take suitable penal action against us.
